In pursuance of authorization of Administrative Department's conveyed vide letter No. HD/ISM/HD/ISM/123/2001 dated: 29-03-2019, the following Departmental in-service Class-IV employees (Matric with science) are hereby deputed to undergo ISM Pharmacist Training course at Government Ayurvedic Hospital, Jammu and Government Unani Hospital, Shalteng Srinagar as the case may be on the following condition that:-

- i) The deputation of above Matriculate departmental Class-IV is purely for undergoing ISM Pharmacist Training course and shall not confer any right / claim upon them to claim promotion to the post of Junior Pharmacist after completion of said training course.
- ii) The post of Junior Pharmacist as and when available will be filled up strictly in accordance with relevant recruitment rules and all eligible's will be considered who fall within the consideration zone.
- iii) The candidates so deputed shall attend their legitimated duties during training period.
- iv) The I/C Institutions shall allow the candidate to join the training only after verification of Matriculation certificate alongwith Marks sheets (Matric + science). The authentication /verification report shall be furnished to this Directorate for purpose of record and reference.
- v) The relevant conditions laid down by department/paramedical council shall be strictly complied with by all concerned officers and candidates in letter and spirit.
- vi) The training shall be imparted strictly in accordance with syllabus presently in vogue in State paramedical council.
- vii) The Deputy Director ISM Jammu/Kashmir, I/C officer Government Ayurvedic/Unani Hospital, Jammu/Srinagar and other concerned officers shall

ensure that the training is conducted in accordance with the prescribed conditions and guidelines, if any, laid down by state paramedical council.
