**NOTIFICATION**

In continuation to this office notification No. Dir-Ayush/NAM/4609 dated 28/03/2023 and No. Dir-Ayush/NAM/5024 dated 05/04/2023, it is hereby informed to all those remaining candidates who have missed their skill assessment test which was held on 5<sup>th</sup> & 6<sup>th</sup> April 2023 at Government Ayurvedic Hospital, Indira Chowk Jammu and at Government Unani Hospital, Shalteng Srinagar for hiring on contractual basis as skilled attendants (Panchkarma / Regimenal Therapies) and masseurs (Naturopathy) under National AYUSH Mission advertised vide No. DISM/NAM/2300 dated 04-06-2021 and No. Dir-Ayush/NAM/4051 dated 01-04-2022 respectively, will now be held on **27<sup>th</sup> July 2023** from 10:00 AM onwards at Government Ayurvedic Hospital, Indira Chowk Jammu (for eligible candidates belonging from Jammu Division) and Government Unani Hospital, Shalteng Srinagar (for eligible candidates belonging from Kashmir Division).

**Note:**

1. List of all eligible candidates has already been published on official website [www.jkdism.in](http://www.jkdism.in).
2. Candidates are required to bring original testimonials, as mentioned in the eligibility criteria of the advertisement notice, at the time of skill assessment test, failing which they will not be allowed to appear;
3. Any candidate found guilty of impersonating or submitting fabricated/tampered documents/testimonials or making false, incorrect or suppressing material information, shall render him/her liable for criminal prosecution under law. Also canvassing/lobbying in any form will entail disqualification of the candidate.
4. Failure of a candidate for appearing in the skill assessment test on the scheduled date and time shall debar the candidate from appearing in the skill assessment test on any subsequent date and shall forfeit his/her candidature.
5. As per the revised selection criteria for the post issued vide No. Dir-Ayush/NAM/2859 dated 30-09-2022, the written test of candidates who qualify the Skill Assessment test will be conducted shortly, hence mere appearing for the skill assessment by the candidate(s) shall not confer any right to claim for contractual hiring under National Ayush Mission.
6. No TA/DA shall be paid for appearing in the skill assessment test.
