Subject: Selection List of waitlisted candidates for the posts of Consultants and Yoga Therapists under National AYUSH Mission

- i. Whereas, the selection list for the post of Programme Manager, Consultants, Finance Manager & Accounts Manager under National AYUSH Mission was issued vide No. DISM/NAM/J&K/2119 dated 09.06.2020 after the approval was received from Ministry of AYUSH, Govt. of India vide letter No. Z.28015/20/2018-H&D Cell dated 26.05.2020; and
- ii. Whereas, as per the condition No.1 of the terms and conditions of the selection list, 21 days was granted to the selected candidates for joining from the date of issuance of the notice, which is reproduced as under:
"The candidate(s) who fail to join within a period of 21 (twenty-one) days from the date of issuance of this notice shall forego their right to engagement which shall be deemed to have been cancelled ab-initio without any further notice and the waiting list shall be operated accordingly"
- iii. Whereas, no candidate(s) joined for the post of Consultants within the stipulated period of 21 days. Besides, two candidates namely Dr. Monika Gupta and Dr. Shafia Mushtaq Allaqaband who were selected for the post of Consultants showed their unwillingness to join through written applications; and
- iv. Whereas, out of 5 posts of Yoga Therapists (Kashmir Division) advertised vide No. DISM/NAM/Hiring/2019/12334, only two candidates were found eligible and were subsequently selected for the post of Yoga Therapists, however three posts of Yoga Therapists (Kashmir Division) remained vacant; and
- v. Whereas, condition No.6 of the terms and conditions mentioned in the advertisement notice issued vide No. DISM/NAM/Hiring/2019/12334 reads as under:
"The selection of the candidates for the posts of Yoga Therapist, Pharmacist, Masseur & Attendants shall be made on the basis of Divisional/ State merit. However, in case suitable candidates are not available within the Division, the candidate opting from outside the Division will also be considered. Selection for other categories of posts shall be made on the basis of state level merit"

Now therefore, based on the consolidated merit and keeping in view the vacant posts of Consultants and Yoga Therapists, following candidates who figured in the waiting list of the consolidated merit of their respective category are hereby provisionally selected on contractual basis under National AYUSH Mission against the below mentioned posts:

Terms & Conditions:

1. The selected candidates can collect their engagement letters from the Office of the Director ISM, Indira Chowk Jammu/Bemina Srinagar. The candidates shall have to join within 21 days from the issuance of this selection list.
2. The candidate(s) who fail to join within a period of 21 (twenty-one) days from the date of issuance of this notice, shall forfeit their right to engagement which shall be deemed to have been cancelled *ab-initio* without any further notice and the candidates in the next waiting list shall be operated accordingly.
3. The selected candidate(s), if working in any other organization, shall have to submit NOC from the competent authority of that Organization.
4. The contract shall be valid initially for a period of one year and will be effective from the date of joining of these candidates.
5. The candidate(s) shall be allowed to join only after production of original testimonials to the concerned DDO, who shall get these testimonials verified from the issuing authorities.
6. The candidate(s) shall also have to execute an undertaking on affidavit from 1st Class Magistrate (on prescribed format) as per the terms & conditions mentioned in the Undertaking and Engagement letter, which he/she will have to submit before the concerned DDO along with joining.
7. The services of the selected candidates shall also be governed by the terms & conditions mentioned in their engagement letters issued by the Director, ISM (NAM) and other service conditions/amendments made from time to time in the interest of the organization.
